Secretary Dunten stated that Kalamazoo Public Schools will be hosting the 2025 PromiseNet Conference. The conference runs from November  $9-11^{th}$ . There will be opportunities for an open forum as well as a gala.

President Griffin let the Board know that the Kalamazoo County Continuum of Care is engaging in a 5-year plan to end homelessness in Kalamazoo County. She encouraged everyone to visit kzoococ.org to learn more.
